The North Tri-county Health District On-site Sewage Regulation 01-2007 states that on-site sewage systems must be installed by the resident owner of the property or an installer certified by NETCHD. This includes any excavation work in regard to the installation of the on-site sewage system. In addition, on-site sewage disposal systems must be designed by the resident homeowner or a Washington State licensed engineer or designer, through the Board of Registration for the Professional Engineers & Land Surveyors.
